

**Around the World with Rihanna**  
**7 Cities, 7 Days, 7 Shows**

**OFFICIAL RULES**

***NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN.  
A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCE OF WINNING.***

**1. HOW TO ENTER**

- a. These rules govern the Around the World with Rihanna promotion (the "Promotion") being conducted by WDZH-FM/98.7 AMP Radio (the "Station") beginning at 7:15am ET on October 29, 2012 and ending at 8:45pm ET on November 4, 2012.
- b. To participate in the Promotion, you must listen to the station each day beginning at 7:15am ET on October 29, 2012 and ending at 8:45pm ET on November 4, 2012 for the announcement of the cue to call. Upon hearing the cue to call, the 25<sup>th</sup> caller to get through to the Station contest line at (313) 298-9870 will win a Qualifying Prize and be entered to win the Grand Prize, upon confirmation of eligibility. At the time of their call, callers will be required to provide all information requested including their full name, complete address (including zip code), day and evening phone numbers and date of birth in order to be eligible to win. In the event that the selected caller is disconnected or is found to be ineligible, the next eligible caller that successfully makes it through on the call-in line and completes their call will be a winner. There is no limit to the number of times a listener may attempt to call in to win, but a listener may be a Qualifying Prize winner only once in the Promotion. There will be up to a total of Seventy (70) Qualifying Prize winners selected on-air during the Promotion dates. The Station is not responsible for telephone service outages, delays, busy signals, equipment malfunctions and any other technological difficulties that may prevent an individual from completing his/her telephone call. Due to delays in the Station online streaming of its broadcast signal, listeners to the online stream may not be able to participate in or may be disadvantaged in participating in on-air contests.

**2. ELIGIBILITY RESTRICTIONS**

- a. The Promotion is open to all persons who are 18 years of age or older and who reside in the state of Michigan, Grand Prize winner and guest must be 18 years of age or older. Grand Prize winner and guest must have valid passports for international travel outside of North America prior to October 29, 2012. Employees of the Station, its licensee, the licensee's parent, subsidiary and affiliated entities, Station's advertising and promotional agencies, its participating sponsors, other radio stations in the Station's metropolitan area, the members of their immediate families (spouse, parent, sibling or child) and those living in the same household of each (whether related or not), are ineligible to enter or win.

This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.

- b. Only one (1) winner per household is permitted in any Station conducted promotion. Listeners are eligible to win prizes valued at \$600 or more in a Station conducted promotion only once every six months
- c. The winner must provide valid government-issued photo identification and provide their complete address, date of birth and phone number to claim a prize. Grand Prize Winner and guest must have valid passports for international travel outside of North America prior to October 29, 2012.
- d. Entrants are required to provide truthful information and the Station will reject and delete any entry that it discovers to be false or fraudulent. The Station will disqualify any entry from individuals who do not meet the eligibility requirements.

### 3. PRIZES

- a. Seventy (70) Qualifying Prizes will be awarded in this Promotion. Each Qualifying Prize is one (1) digital download of Rihanna's 7<sup>th</sup> Album, "Unapologetic" available everywhere Monday, November 19, 2012. The Approximate Retail Value ("ARV") of each Qualifying Prize is \$10.00. The winners will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the Qualifying Prize.
- b. One (1) Grand Prize will be awarded. The Grand Prize is a trip for two (2) people to Mexico City, Toronto, Stockholm, Paris, Berlin, London and New York and includes the following:
  - i. Coach airfare for the Grand Prize winner and one (1) guest to the following locations on the following dates:
    - November 13, 2012 to Los Angeles, CA from Detroit, MI
    - November 14, 2012 to Mexico City, Mexico from Los Angeles, CA
    - November 15, 2012 to Toronto, Canada from Mexico City
    - November 16, 2012 to Stockholm, Sweden from Toronto
    - November 17, 2012 to Paris, France from Stockholm
    - November 18, 2012 to Berlin, Germany from Paris
    - November 19, 2012 to London, England from Berlin
    - November 20, 2012 to New York City, NY from London
    - November 21, 2012 to Detroit, MI from New York City
  - ii. One (1) night hotel accommodations (one (1) room, standard double occupancy) in each of the following destination cities: Los Angeles, Mexico City, Toronto, Stockholm, Berlin, London, and New York City ("Destination(s)")
  - iii. Two (2) tickets to see Rihanna in concert each night at each Destination:
    - November 14, 2012 Mexico City, Mexico

November 15, 2012 Toronto, Canada  
November 16, 2012 Stockholm, Sweden  
November 17, 2012 Paris, France  
November 18, 2012 Berlin, Germany  
November 19, 2012 London, England  
November 20, 2012 New York City, NY

- iv. Ground transportation for the winner and one (1) guest in each international Destination is included in the Grand Prize.
- v. The ARV of the Grand Prize is \$4,145.00.

Certain travel restrictions may apply. Travel arrangements will be made by the Station. Prize is subject to availability. If the winner cannot travel on all of the dates specified by the Station, the winner may be disqualified and an alternate winner may be selected in the Station's sole discretion. The Grand Prize winner and his or her guest must each have a valid passport for international travel outside of North America prior to October 29, 2012. All other costs not specifically stated herein, including but not limited to those of, taxes, meals, tips and ground transportation to/from the airport of trip origination, are the responsibility of the winner. The winner and travel companion must both be 18 years of age or older, must travel on the same itinerary and are responsible for obtaining all required travel documents, including, without limitation, passports for international travel. If applicable, the winner may be required to present a valid credit card upon hotel check in to cover any incidental expenses incurred during the winner's stay. The winner and travel companion must sign a Publicity, Liability Waiver and Travel Release form prior to traveling. If a selected event is unable to take place as scheduled, for reasons such as cancellation, preemption, postponement or unavailability, or for any reason beyond the control of the Station, the Station's sole responsibility to the winner will be to award the remaining available portion of the prize and no substitution or compensation will be provided for the unawarded portion of the prize. The Station reserves the right to remove from the Grand Prize trip or to deny entry to any of the concerts for the winner and/or travel companion if either engages in a disruptive manner or with intent to annoy, abuse, threaten or harass any other person on the trip.

- c. All Qualifying Prizes or prize certificates may be picked up at the office of the Station at the address below. The Qualifying Prize winners will forfeit any Qualifying Prize not claimed within thirty (30) days of winning. In the event that a Qualifying Prize or prize certificate is mailed to the winner, it will be with the prior written consent of the winner and therefore, winner assumes the risk of its loss. The Grand Prize or Grand Prize certificates will be sent to the Grand Prize winner in a manner determined by Station. The Station is not responsible for the safe arrival of a prize or prize certificate.

- d. There is no substitution, transfer or cash equivalent for prizes, except that the Station may, at its sole discretion, substitute prizes or cash of comparable value. The prizes are expressly limited to the item(s) listed above and unless otherwise expressly specified, do not include taxes, gratuities or any other expenses. Other restrictions may apply.

#### 4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of the Station management with respect to the Promotion are final.
- b. Seventy (70) Qualifying Prize winners will be selected on-air as described in Section 1 of these Official Rules.
- c. One (1) Grand Prize winner will be selected on Monday, November 5, 2012 at approximately 8:45am ET in a random drawing of all Qualifying Prize winners.
- d. Odds of winning a Qualifying Prize depend on the order and number of calls received. Odds of a Qualifying Prize winner winning the Grand Prize are 1 in 70 (or less if any Qualifying Prize winner is disqualified from entry for the Grand Prize).
- e. Qualifiers must listen to the Station to win a Qualifying Prize but do not need to be present to win a Qualifying Prize. The Grand Prize winner does not need to listen to the Station or be present to win the Grand Prize.
- f. Qualifying Prize winners will be notified of winning at the time of their winning phone calls. The Grand Prize winner will be notified of winning by telephone immediately following the random drawing. If the Grand Prize winner cannot be contacted within 24 hours of notification attempt, or if the Grand Prize winner and his/her guest fails to sign and return the required affidavit of eligibility and/or liability/publicity release or fails to provide a copy of their valid passports by 5:00pm PT on Wednesday, November 7, 2012, or if a prize or prize notification is returned as undeliverable, the potential Grand Prize winner forfeits the Grand Prize and an alternate Grand Prize winner will be selected in a random drawing of all remaining Qualifying Prize winners.

#### 5. CONDITIONS

- a. Payments of all federal, state and local taxes are solely the responsibility of the winner. The winner will be required to complete and submit an IRS Form W-9 with the winner's full Social Security Number or the equivalent for receipt of any prize valued at \$600 or more or for any prizes awarded by the Station (or any other CBS Radio station in Station's market) in a calendar year with an aggregate value of \$600 or more. Failure to submit a complete W-9 or equivalent will result in forfeiture of the prize. Such winnings of \$600 or more will be reported to the IRS.

- b. By participating in the Promotion, the winner agrees to have the winner's name, voice and likeness used in any advertising or broadcasting material relating to the Promotion without additional financial or other compensation, and, where legal, to sign a publicity release confirming such consent prior to acceptance of the prize.
- c. Prior to awarding any prize or prize certificate, the Station, in its sole discretion, may require Promotion winner (and any travel companion(s) or guest(s)) to sign a liability release, agreeing to release and hold harmless the Station, its licensee, the licensee's parent, subsidiary and affiliated entities, their respective officers, shareholders, directors, employees, agents and representatives and all of their successors and assigns from and against any and all claims or liability arising directly or indirectly from the prize and participation in the Promotion.
- d. If for any reason this Promotion cannot be executed as planned, including, but not limited to, as a result of infection by computer virus, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the control of the Station that corrupt or affect the security, administration, fairness, integrity or proper conduct of the Promotion, or if the Promotion is compromised or becomes technically corrupted in any way, electronically or otherwise, the Station reserves the right to cancel, terminate or modify the Promotion. If the Promotion is terminated before the original end date, the Station reserves the right to select the winners by random drawing from among all eligible non-suspect entries received as of the termination time/date or otherwise modify the procedure for selecting winners.
- e. The Station, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of the Station's website. Failure to comply with the rules of the Promotion may result in a contestant's disqualification and/or forfeiture of any prize or prizes. If the Station makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a Promotion, the Station reserves the right to disqualify that entrant from entering and/or winning future Promotions and to prosecute and seek damages to the fullest extent permitted by law.
- f. The Station reserves the right to make changes in the rules of the Promotion, including, without limitation, the substitution of a prize of equivalent value, which will become effective upon announcement. If due to circumstances beyond the control of the Station, any competition or prize-related event or travel is delayed, rescheduled, postponed or cancelled, the Station reserves the right, but not the obligation, to cancel or modify the Promotion and shall not be required to award a substitute prize.
- g. The Station is not responsible for typographical or other errors in the printing, the offering or the administration of the Promotion or in the announcement of a prize.

- h.
